1 Formation

13008037 Canada Association is a corporation without share capital which was incorporated on May 11, 2021, under the Canada Not For Profit Corporations Act. It operates as a Registered Charity under the name Youth En Route ("YER").

2 Operations

YER promotes and facilitates cycling for schoolchildren by providing cycling education, refurbished bicycles and other equipment.

3 Registered Charity status

On July 21, 2022 YER was granted Registered Charity status by the Canada Revenue Agency, it previously operated as a non-profit organization.

4 Additional information to comply with the disclosure requirement of the Charitable Fund-Raising Act and Regulation
